## Monthly Report – October 2008

### Overview of Activities

- **The Massachusetts Department of Elementary and Secondary Education authorized Uxbridge Public Schools to participate in FREE professional development opportunities as they become available throughout the 2008-2009 academic year - as a means of improving programs and services for students with disabilities.**
- **The Department of Pupil Personnel Services portion of the district website is up-to-date and current.**
- **The Department of Pupil Personnel Services, in accordance with IDEA 2004 and Massachusetts General Law, has completed a mass mailing of the Notice of Procedural Safeguards to all families with students currently serviced on an Individual Education Program (IEP).**

### Subject Activities

Throughout the month of September, the Director of Pupil Personnel Services met with Uxbridge Public School service providers in the areas of special education, English language education, 504 compliance, and guidance/wellness.

The Department of Pupil Personnel Services in cooperation with the Uxbridge Public School Special Education Parent Advisory Council (USEPAC) put together a mass mailing of the Notice of Procedural Safeguards along with information pertaining to the PAC - in accordance with the Reauthorization of Individuals with Disabilities Education Improvement Act of 2004 and Massachusetts General Law.

The Director of Pupil Personnel Services attended out-of-district meetings in the following communities: Milford, Swansea, Plainville, Harvard, and Lancaster, Massachusetts.

The Director of Pupil Personnel Services continues to examine the special education budget on a monthly basis - in cooperation with the School Business Manager, and Superintendent of Schools.

The Director of Pupil Personnel Services continues to be an active member of the Administrative Team meeting process twice per month. As well, the director participates on the Uxbridge

Interagency Roundtable, Gifted and Talented Education Team, and the Uxbridge Public Schools Technology Team.

The Director of Pupil Personnel Services continues to work in partnership with the Commonwealth of Massachusetts' Department of Elementary and Secondary Education in the area of grant writing as a means of improving programs and services for students with disabilities.

Phase III observations for the special education faculty at Uxbridge High School have been completed. Phase I observations have begun; all special education faculty at Uxbridge High School will be observed by the Director of Pupil Personnel Services.

On October 22, 2008, the Director of Pupil Personnel Services read to Mrs. Higgins 3<sup>rd</sup> grade class as part of Community Reader Day at the Taft Elementary School.

### **Professional Development Activities**

The Massachusetts Department of Elementary and Secondary Education, in approving Grant 274, authorized Uxbridge Public Schools to participate in FREE professional development opportunities as they become available throughout the 2008-2009 academic year as a means of improving programs and services for students with disabilities.

The Director of Pupil Personnel Services continues to offer department support in the areas of relicensure guidance/technical support – so that Uxbridge Public Schools special education faculty/staff remain current in the ever-changing laws of the Commonwealth. This technical support and guidance is offered throughout the academic year in partnership with the Department of Education and Framingham State College.

The Director of Pupil Personnel Services continues to be an active member of the English Language Learners Low Incidence Group and the Blackstone Valley Educational Collaborative Regional monthly meeting – as a means of remaining current with local, state and federal legal mandates.

The Administrators for Special Education in the Commonwealth of Massachusetts held their quarterly meeting at the Best Western Conference Center in Marlboro, MA. on October 31, 2008. The Director of Pupil Personnel Services was in attendance to meet and talk with other leaders in the field of special education.

On October 8, and October 17, 2008, the Uxbridge Public Schools Special Education Parent Advisory Council held its initial meetings of the 2008-2009 academic year at 7:00p.m. in the library of the Whitin Middle School. ### **General Department Information**


